MCRSA


- **Medical Cannabis Regulation and Safety Act (MCRSA)**
 - AB 243, AB 266, SB 643 of 2015, and SB 837 of 2016
 - Created first state regulatory framework for medical cannabis
 - Dual licensing system
 - Responsibility for state licensing split between three state entities
 - Six major license types
- **Laws provide skeleton of regulatory framework; provides flexibility and leaves details to regulatory process**




Implementation of the MCRSA




Licensing Authorities
